EXCERPTS FROM THE RULES OF THE CLUB

Rule 6 Membership Classes

- a) Full Members:- Persons of good character and social repute and who has attained the age of 18 years.
- b) Country Members:- Any member who lives out of Arusha region.
- c) Temporary Members:- Available to non- residents of Arusha for a period or periods not exceeding 3 months in any one year.

NOTES

- 1) Membership rights extend to member's spouse. Member's children under of 18years or above 18 but still schooling may enjoy Club facilities.
- 2) Sports facilities are only available to members of the Sports sections. See the Captain of the sports of your interest.

Rule 8 Reciprocal Arrangements

The Club has reciprocal arrangements with some clubs. Obtain a list from the Club Manager

Rule 10 Guests

- a) A member accompanied to the club by visitors must register them at the gate, and pay the requisite fees and pay for any expenses that may be incurred at the club by the guests. A resident of Arusha can be a guest at the Club only once a calendar month.
- b) The Committee,, may at its discretion stop any or all the guests visiting the Club
- c) A person suspended or dismissed from the Club is not allowed to be a guest.

Rule 11 Election of Member

- a) Pending the determination of the application for membership, the applicant may enjoy the facilities of the Club as a temporary member, but shall not enjoy the rights and privileges accruing to a full member
- b) An applicant whose application is not accepted shall not be eligible for consideration of membership for a period of 12 months from the date of rejection of the application.
- c) On approval of the application, the applicant will be notified of the Committee's decision in writing. No reasons will be given for rejecting an application.
- d) Subscriptions shall become due and payable from the date of proposal of the application.

Rule 12 Fees & Subscriptions

Within 7 days of being notified of acceptance of an application, the applicant shall pay

- a) Entrance fee
- b) Development Levy
- c) Membership subscription fee

The acceptance shall lapse if payment is not made within 14 days of being notified of the acceptance.

Fees are not refundable

Rule 14 Forfeiture of Membership

- a) Misconduct - a MEMBER may be reprimanded, fined or dismissed for any misconduct within or outside the Club
- b) A member may be dismissed for being indebted to Club

Rule 28 Voting at meetings

Temporary members may attend meetings but may not vote

By - Law 8 Club Servants

No Club servant shall in anyway be reprimanded or punished by a member. Any fault found should be reported to the Management Committee with all necessary evidence

By - Law 9 Breakage & Damage

Any member breaking or damaging Club property shall pay double the cost of such a property or the cost of its repair

By - Law 10 Suggestions and Complaints

These must be made in writing to the Management Committee

By - Law 13 Dress Code

Members and their guests while in the Club house after 20:00hours shall be decently dressed. Sportswear such as shorts, caps, shoes with nailed soles, beach wear shall not allowed, and the wearer who shall not be served may be asked to leave the Club House by any member of the Management Committee.
